<p>We refer to your correspondence dated March 22, 2018 received via PSE EDGE wherein Alliance Global Group, Inc. is requested to give clarification and/or confirmation on the news article under BusinessWorld Online entitled "Another casino set to open in Boracay" published in the March 21, 2018 issue of the Philippine Daily Inquirer, which reported in part that:</p> <p>"APART from Macau casino operator Galaxy Entertainment Group Ltd.'s planned integrated resort complex, a new casino will rise on Boracay Island as part of a growing number of new gaming facilities being set up outside the capital that can allow the Philippines to tap the potential of the growing premium Chinese mass market.</p> <p>Philippine Amusement and Gaming Corp. (PAGCOR) Chairperson Andrea D. Domingo told reporters on Tuesday the new casino owned by Resorts World will open at Savoy Hotel in Boracay, which may be operational in four months.</p> <p>'They placed all their requirements and application since 2014. That one also has been approved and they have built the hotel,' Ms. Domingo said on the sidelines of the ASEAN Gaming Summit in Pasay City, while noting that a contract has yet to be signed. . . ."</p> <p>We wish to confirm that the company involved in this casino project is a subsidiary of Alllance Global Group,inc.</p> <p>We trust the foregoing satisfies the requirements of the Exchange.</p>
